After meeting with you to complete your home study, Lynn and I would be most honored to have you as adoption clients also. Lynn and I will do our personal best to make your adoption a pleasant experience and fulfill your dream of quickly becoming a family! We know that you will make awesome adoptive parents.

Our New Born Adoption Services program is a wonderful adoption opportunity that we believe will provide the child that you are longing to adopt. Last year, Lynn and I located 12 birth mothers and 9 of them followed through by placing children with our adopting families. This year, we are anticipating many more such adoption situations as we are heavily advertising by 1) listing our services to assist birth mothers who are intending to place their child for adoption in all of the yellow pages, super pages, talking phone books, yellow books etc in Martin, St. Lucie and Indian River Counties, 2) having a large ads in two Hometown Newspapers every week for distribution in 8 regions, 3) offering our birth mother services on our radio program on 89.9 Fm on Saturday mornings at 830am which is also on our www.HopeBroadcasting.org webcast, 4) having flyers, posters and adoption magazines placed in high schools, colleges, medical centers, OBGYN, public health clinics, jails, churches, malls, social services etc. in 3 counties by our outreach director and counselor, Debra Thompson MA, 5) listing our services at the local theater on their movie guide, 6) having signs at Winn Dixie and K-Marts, 7) adoption seminars and workshops, 8) advertised on www.hopeforbirthmothers.org, 9) exposure throughout the Christian community through large ads in 3 county wide Shephards Guide Magazine which is distributed to hundreds of churches and 10) having a substantial web presence through our websites which are at the top of Yahoo and Google which offer assistance to birth mother with the availability to phone our 24 hours birth mother hot line at 1-800-620-HOPE! HFF is spending approximately \$7,000 a month in advertising related expenses to facilitate your adoption!

Through every part of your adoption process, you also will be directed assisted by my darling wife, Lynn and the birth mother will be assisted by Debra Thompson. I will of course be available for any needs that require my attention or clinical skill.
